

CommBank Yello – discount on More nbn® plans

The offer of a monthly discount off the recommended retail price (RRP) of a More nbn® plan for 36 months for new services (36 Month Plan Discount), or 24 months for existing services (24 Month Plan Discount) is only available to eligible CommBank Yello customers that qualify for the relevant CommBank Yello tier (see sections 2 and 4), who apply the offer to a service by taking the steps set out in section 5, and who use an eligible CommBank online bill payment method. Eligible CommBank Yello customers that qualify for the relevant CommBank Yello tier can also receive a discount off the RRP of a Wi-Fi Router Pack (see section 3 and 4) by taking the steps set out in section 5 and paying with an eligible CommBank online bill payment method. The discounts available under this offer are as outlined in section 2, section 3 and/or in Schedules 1-4. To access this offer you must sign up to a new nbn® plan via the More website and enter a unique offer code or apply a unique offer code to an existing service via the More Customer Portal. To maintain discounts available under this offer, you must continue to meet the eligibility requirements of a CommBank Yello tier (see section 4) and continue to pay for your discounted More nbn® plan with an eligible CommBank online bill payment method (see section 12).
